CWC CHOSEN TO INSTALL TELECOMS FOR PANAMA NATIONAL ASSEMBLY

Cable & Wireless Panama, part of Cable & Wireless Communications (CWC), has won a managed services contract to install and maintain telecommunications and IT systems in the new National Assembly building in Panama City.

Cable & Wireless Panama will install telecoms equipment, create a Local Area Network (LAN) covering the building and will use fibre optic cabling to connect the building to other sites and offices of the Panamanian parliament. The company will also manage the relocation of data and virtual services from the existing National Assembly building to a data centre in the new building.

As part of the contract, Cable & Wireless Panama will configure, maintain and provide training for voice and data communications, computer security and power protection for a period of three years.
